2025 SEASON KICK-OFF NEWS AND UPDATES

Dear Nansemond Swim Club Community,

I am thrilled to begin my second term as president of NSC and warmly welcome back all our returning members as we eagerly anticipate a bright and sunny 2025 season.

During the last season, we made significant investments in repairs and upgrades to the club including new roofs for the main building and pavilions, as well as replacing the pump motor and impeller for our water filtration system. Additionally, we completely renovated the snack bar to introduce our new point of sale system, enabling us to accept credit card and electronic payments.

In the off-season, we focused on revitalizing the old tennis court area. When we reopen for the 2025 season on May 24th, members will be able to enjoy our two new pickleball courts and expanded recreational space. The basketball court is being relocated into the fenced area to enhance safety for our children and free up parking. Other improvements include partial replacements of picnic tables and deck furniture, new fencing around the baby pool, a new diving board, refurbishment of in-pool lighting and upgraded flooring in both restrooms.

As you may know, Virginia's minimum wage increased this year. To ensure NSC remains financially viable, the 2025 dues will be \$500, along with a \$25 capital assessment to continue funding essential projects at NSC.

On May 2nd, board member Keith Nierman will host his annual NSC Benefit Golf Tournament at Sleepy Hole Golf Course. We invite businesses and individuals to consider partnering with us in support of this fundraising initiative. All proceeds from the tournament will directly contribute to the tennis court refurbishment project.

We are eager to welcome you back for the 2025 season, filled with exciting events such as movie nights, family cookouts, and swim team activities. NSC Pool Memberships are still available this season, so please refer your friends and neighbors for membership. Looking forward to seeing you at the pool!

_____ Option 1: PAID IN FULL Membership. Membership Fee of **\$440** plus current annual dues & maintenance fee of **\$525 = \$965**.
I understand that the nonrefundable membership fee of \$440 secures my NSC Membership for as long as dues are paid annually.

_____ Option 2: PROVISIONAL Membership. Membership Fee of **\$440** paid over 2 years (\$220) + current annual dues & maintenance fee of **\$525 = \$745**. Once the membership fee of **\$440** is paid in full, I will be a full member and will pay annual dues only.

Provisional Members pay \$745 for two years to become a full member. Full Members then pay Annual Dues during year 3 and beyond. Annual dues are payable each April and are currently \$500 + \$25 maintenance fee = \$525. Annual dues are pro-rated if application is between June 30 - Labor Day. Membership fees and dues must be current to join swim team. Membership fees must be paid in full to receive a membership certificate.
